

INN-Reach DCB Application Profile: Lending and Borrowing

Abstract: This application profile describes the method in which the INN-Reach DCB broker application manages circulation transactions using the NCIP protocol.

1. Introduction

This profile is the INN-Reach DCB Application Profile of the NISO Circulation Interchange Protocol (NCIP). It describes the functions, applications, and the operating environment in which the INN-Reach DCB application manages circulation transactions for libraries participating in an INN-Reach System via Innovative's Direct Consortial Borrowing (DCB) system.

The base standard that enables this communication is NCIP. This profile is based on that protocol, as well as the supporting NCIP Implementation Profile 1.0.

2. Description of Application Area

Through the INN-Reach DCB application (INN-REACH DCB), users of one agency can request and borrow items from another agency within a consortium. INN-REACH DCB facilitates the transfer of user and item data between disparate circulation applications, thereby allowing an agency to manage borrowing for local patrons, lending to non-local patrons, and/or managing local control of items belonging to another agency. An agency may participate both as an item agency and as a user agency, but for any given circulation transaction an agency must be either an item or user agency.

INN-REACH DCB serves as the NCIP message initiator in this profile. The set of services potentially invoked at item and user agencies are not identical. Ideally, systems will support both set of services; however it is possible to implement only a single set of services, with the result of supporting either borrowing (user agency) or lending (item agency) roles. The responding application is expected to manage transactions on behalf of both the item and user agencies.

INN-REACH DCB is used in combination with the local circulation system as the user interface for users and staff users. This user interface allows users to place requests, view the current status of a request, cancel requests, or request renewals. INN-REACH DCB can be used by staff to perform all user agency and/or item agency functions.

In response to actions taken by users, INN-REACH DCB manages the following actions automatically:

- Performs all necessary communication for the completion of a circulation transaction.
- Seeks the necessary information from both the user and item agencies.
- Applies all business rules (e.g. circulation policies) as defined by the consortium.
- Makes any policy determination (e.g., due date, authorization, etc.) on behalf of the borrowing or lending agency.
- Updates each circulation application as requests move through their lifecycle.

INN-REACH DCB relies on local circulation systems to respond appropriately to messages. INN-REACH DCB may use the services defined in this profile to instruct a local application to place holds, check items in and out and renew items.

This profile outlines the interactions between INN-REACH DCB, the item agency, and the user agency. It does not prescribe how the item agency and user agency accomplish subsequent tasks (e.g., creating temporary records). However, it should be noted that INN-REACH DCB tracks users as individual patrons, rather than as a single “institutional” user (also known as the “pseudo-patron”) to whom all circulated items are checked out. The user information that the application communicates in the NCIP messages (e.g., in the UniqueUserId element or the User Information Name element) is specific to the individual patron.

3. Use Case

Libraries that do not use a Millennium or Sierra library automation system but participate in an INN-Reach resource sharing system via Innovative's DCB system can employ this profile to send NCIP messages from the INN-Reach system to their local library automation system. Support is provided for patron authentication and communication of all circulation activities that occur on the DCB system.

4. Roles

This profile defines three roles to which an application may claim conformance:

ROLE	DESCRIPTION
INN-Reach DCB	An application that provides a user and staff interface on behalf of a consortium, a user and/or an item agency. INN-REACH DCB initiates NCIP services on behalf of user or item agencies but is itself neither a user nor an item agency.
Item Agency	The agency to which a specific physical information resource belongs.
User Agency	The agency to which a user (person) is affiliated through registration and/or membership.

5. Transport Protocol

INN-REACH DCB employs HTTPS as the transport protocol.

The responder shall respond using the same connection, and therefore the same transport protocol, that was used to send the message.

6. Security and Privacy

This profile requires the transmission of confidential personal information by the user agency to other agencies. While it provides for the use of a reasonably secure transport protocol (HTTPS), this profile is not intended for use where such sharing of confidential personal information is not acceptable.

The implication of this is that a user agency participating in activity according to this profile is assumed to trust the other agencies with which it shares this confidential user information.

Authentication of the user is assumed to occur prior to invoking further NCIP services at the direction of the user. This profile assumes that conforming user agency applications support the use of the Lookup User service for this purpose.

Mediation in the requesting process by staff is outside the scope of this profile.

Responding applications might require From Agency Authentication and/or From System Authentication elements in the initiation header of some or all messages. Whether they do, and if so what the value should be, is outside the scope of this profile, as are the implications for the consortium if some applications are not able to provide this in initiation messages.

7. Messages and Data Elements

The Messages Summary tables define the NCIP messages either initiated by or required as responses by INNREACH DCB, and summarize the data elements of each message. For more detailed information on these elements, see:

8. Guidelines for Implementers

The guidelines listed below are intended to assist vendors in implementing this profile. As guidelines, they are non-normative and represent non-protocol assumptions or options that might be employed by a well-designed application that is conformant to this profile.

The success of inter-system interoperability depends on many factors beyond proper coding and decoding of standards-based messages. These guidelines list some of the additional considerations libraries and systems should address as part of their NCIP implementation.

General Performance Issues

Users can be expected to search and request materials at any time of day. The listening port should be open as close to 24*7*365 as possible. To avoid problems arising from stale data, Circulation Applications are expected to process transactions in “real time” mode. If a Circulation Application is not processing transactions in real time, the responding NCIP application should refuse the connection attempt from INN-Reach DCB.

Messages

- In order to support the widest range of functionality, while not required by the protocol or the profile, applications should send the most complete version of any message or message response including optional data.
- Applications should provide means of sending repeat messages in the event where the first message was not received or the response indicates the message could not be understood. Detection of unintentional duplication of messages is the responsibility of the application and not within the scope of the profile.
- It is the responsibility of the item-managing application to determine whether the request requires placing a hold or retrieval from stacks. In either case, the appropriate action occurs at the item agency without staff intervention at either the item or user agency. How the item is delivered is beyond the scope of the profile, as is the way in which non-NCIP errors are detected and handled by INN-Reach DCB and/or some local system at the user or item agency
